Distributing Scholarships to Poor and Meritorious Students

The scheme **LALITHAMMA VIDYA VIKASA SCHOLARSHIP 2024-2025** is started by Sri Chaganam Gowrishankar garu with his own funds of Rs.15 lakhs to distribute to poor and meritorious students of forward caste category every year, in loving memory of Smt Chaganam Lalithamma garu his beloved mother through Chaganam Lalithamma Bhaskararao Memorial Trust Pellakur, Tirupathi dist.AP.

CRITERIA & CONDITIONS FOR SANCTION OF SCHOLARSHIP

60 students of poor and meritorious from **forward castes** are selected for scholarship for the year 2024-25

1. 1st year Intermediate 10 students
2. 2nd Year Intermediate 10 students
3. 1st Year Undergraduate Professional Course 10 Students
4. 2nd Year Undergraduate Professional Course 10 Students
5. 3rd Year Undergraduate Professional Course 10 Students
6. 4th Year Undergraduate Professional Course 10 Students.

10 students in each class are selected with proportion of **6 Boys and 4 Girls** of poor and meritorious forward caste candidates are only eligible to apply.

The scholarship amount of **Rs. 25000/** will be given to each selected student in all above classes.

Total **60 students** from Tirupathi & SPSR Nellore districts will be selected as per the following preferences.

1. First preference will be given to Orphan child students who are depending on guardian in all classes

(Inter 1st year to 4th year under graduate course)

2. Second preference will be given to single parent (Mother) child in all classes
3. Third preference will be given to Single Parent (Father) child in all Classes
4. Last preference will be given to the students who have parents in all classes

Important Note:

1. All semesters in a Academic year will be taken in to account for calculation of percentage of marks in respective class for selection of merit students
2. All incomes from all sources will be taken in to account for the calculation of poor financial status of the applicant
3. Preference will be given to government college students
4. The applicants who study in Andhrapradesh colleges are only eligible to apply
5. The Students of SPSR Nellore district and Tirupathi district are only eligible to apply
6. The applications of SON/DAUGHTER belonging to Government employees, Government corporation employees, retired government employees and corporation employees and highly earning people are not considered for scholarship.
7. The applications of other districts and other states other than SPSR Nellore and Tirupathi are not considered for scholarship. The applications of OTHER CASTES except **FORWARD CASTE** will not be considered

for scholarship. The income limit should not be more than **Rs. 120000/-** (one lakh twenty thousand) per Annum

8. There will be **physical verification** to know about the actual financial status of the candidate

9. The recommendations will not be entertained at any cost. Moreover it will lead to disqualification of the application

10. The decision of Scholarship Selection Committee is final .No correspondence will be entertained in case of merit list and other issues
